# SHELL SCHEME BOOTH DETAIL & TERMS AND CONDITIONS

## Terms & Conditions

1. Booth / Raw Space will be reserved upon receipt of this Registration Form.
2. Confirmation of Booth / Raw Space is only valid upon receipt of full payment.
3. The organizer reserves the right to relocate Booth / Raw Space allocation.
4. **FULL PAYMENT** must be made within 7 days after issuance of invoice.
5. Compound schedule for cancellation of participation (with registration form) :
  - 60 days before the event date : 50%
  - 30 days before the event date : 100%
6. All raw / custom designed booths must maintain minimum 50% visibility without blocking other booth around.
7. All raw / custom designed booth must submit before :
  - a) 3D design layout
  - b) Refundable Security Deposit of RM 1,000.00 / 100sqft.
8. Exhibitor is liable for the cost of repair in the event of damage caused to the exhibitor booth or hall.

## Payment

1. **Full payment** payable upon registration and confirmation of booth.
2. The organizer reserves the right to release registered Booth / Raw Space if payments are not received by the stipulated deadlines.

## Cancellation by the Organizer

1. The organizer shall inform exhibitor of its intention to cancel the event in writing by way of email and or facsimile.
2. In the event that Pet Kingdom Expo is cancelled or rescheduled for any reasons whatsoever beyond the control of the organizer, the organizer will not be responsible for any loss of business, loss of profits, damage or expenses of any nature that the exhibitor may suffer. In such eventuality there shall be no refund of all the money paid.
3. If the organizer cancels the event at its own accord prior to the commencement of the event, the organizer shall refund to the exhibitor all the money paid free of interest.

## Cancellation by the Exhibitor

1. The exhibitor shall inform the organizer of its intention to cancel its participation in writing by way of email or facsimile.
2. In the event the said cancellation was made 60days or less before the event date :
  - a) In the event full payment has been made, the organizer shall be entitled to forfeit all the sum paid ( "Forfeiture Sum" ).
  - b) In the event full payment has not been made, the organizer shall be entitled to forfeit all the sum paid, if any, and the exhibitor shall forthwith pay the difference between the sum forfeited herein, if any, and the Forfeiture Sum.
3. The exhibitor shall be liable to pay late payment interest on all outstanding amount at the rate of 1.5% per month calculated on a daily basis from the due date until the date of full settlement.
4. In the event that legal proceedings is necessary for the organizer to recover any money due and payable by the exhibitor, the exhibitor shall fully indemnify all the legal cost and / or any other cost or disbursement whatsoever which shall be incurred by the organizer.

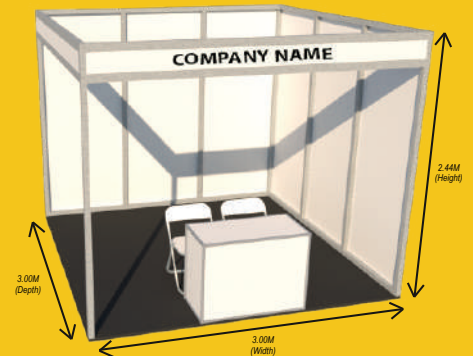
